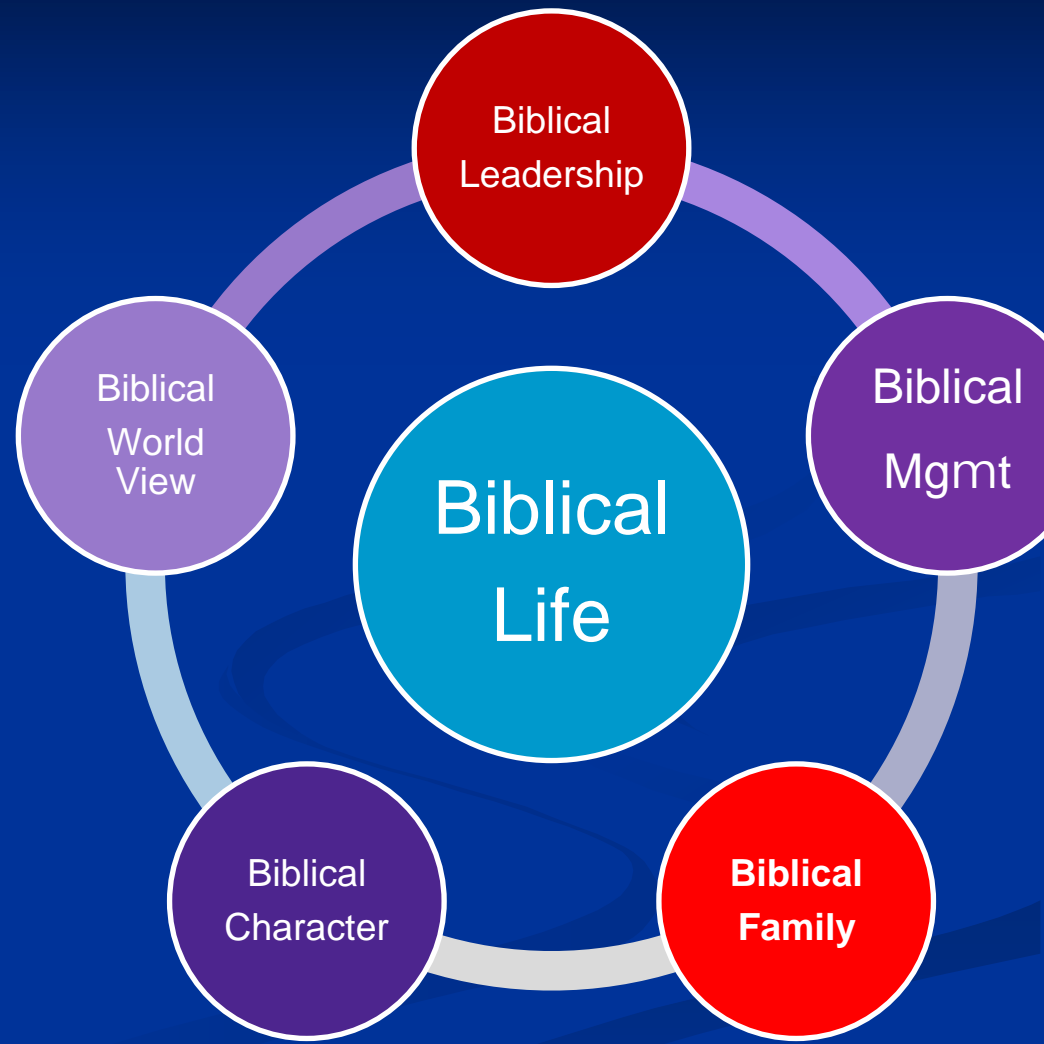

2. Move to Taiwan in 2012 for Chinese Speaking Group
3. 2012-2018 : Total students over 1000.
  - CEP 30 classes, 10% in Taiwan, 90% in China.
  - PEP 26 classes, 46% in Taiwan, 54% in China
